Zehnder Group acquires majority stake in China's Fortuneway, manufacturer of heat and humidity exchangers

Gränichen (CH), 3 November 2020 – The Zehnder Group (SIX: ZEHN), a leading international provider of complete solutions for a healthy indoor climate, is acquiring 51% of the shares in Zhongshan Fortuneway Environmental Technology Co., Ltd. The Chinese company specialises in the development, production and sale of enthalpy exchangers for humidity and heat recovery. With this acquisition the Zehnder Group further expands its international heat exchanger business.

About Fortuneway

Despite only being founded in 2018, Zhongshan Fortuneway Environmental Technology Co., Ltd has already made a name for itself as a provider of enthalpy exchangers and polymer membranes for humidity and heat recovery. The company is headquartered in Zhongshan (in China's Guangdong province) and has been a Zehnder Group supplier since 2019. Fortuneway employs around 50 employees and is expected to achieve a turnover in the region of EUR 3 million in 2020. The Zehnder Group will be retaining both the workforce – including management – and the site as part of the acquisition.

Expansion of the heat exchanger business

Heat exchangers are the most recent addition to the Zehnder Group's five product lines, alongside residential ventilation, air cleaning systems, radiators, and heating and cooling ceiling systems. The heat exchanger product line also includes enthalpy exchangers, which recover humidity in addition to heat. Ventilation units in China feature a high proportion of enthalpy exchangers. Today, the majority of these are made out of paper, although there is a clear trend towards the use of polymer membranes, as these are more efficient, durable and hygienic. With this acquisition, the Zehnder Group is expanding both its technology and product portfolios, while also exploiting the potential for growth in China.

The closing of the purchase is expected to take place in the coming months and is subject to customary closing conditions. The parties have agreed not to disclose the purchase price.
